In consideration of being permitted to participate in the LBI Longboard Classic ("Contest"), I personally and for all of my personal representatives, assigns, heirs and next of kin:

1. Hereby Release, Waive, Discharge and Covenant Not to Sue the Wooden Jetty, Alliance for a Living Ocean, the Township of Long Beach, the Diamondheads, and all related officers, directors, agents, members, employees, other Contest competitors, Contest sponsors, and Contest Judges (hereinafter "Releasees") from all liability to the Undersigned on account of injury to the person or property or resulting in death of the Undersigned, whether caused by the negligence of Releasees or otherwise while the Undersigned is participating in the Contest and after-party.
2. Hereby Agree to Indemnify and Save and Hold Harmless the Wooden Jetty Surf Shop, Alliance for a Living Ocean, the Township of Long Beach, the Diamondheads, and all related officers, directors, agents, members, employees, Contest sponsors, and Contest Judges, due to the presence of any action of the Undersigned in or about the Contest and whether caused by the negligence of the Releasees or otherwise.
